<p><b>Objectives and Investment Policy</b></p>								
<p>The Fund aims to generate positive returns and preserve capital principally by buying debt instruments that offer a yield but also the potential to convert to shares (convertible bonds). The Fund is actively managed and not managed with reference to a benchmark.</p> <p>The Fund aims to achieve a return that exceeds LIBOR.</p> <p>The Fund has a global focus. The Fund invests in bonds which are either Investment Grade or non-Investment Grade in developed and emerging market countries.</p> <p>The Fund invests primarily in convertible bonds that are trading close to their fixed income value. These convertible bonds are less sensitive to share price movement and are more bond-like in their risk profile, offering protection if shares prices fall. If share prices rise, they can still participate in this rise as they become increasingly equity-like.</p> <p>Any income less expenses earned by the Fund will not be distributed to investors but will be accumulated in the net asset value per share of the Fund instead.</p> <p>The value of the Fund is calculated and published daily and investors can buy and/or sell shares on any day in which the banks are open for business in Dublin and London.</p>	<p>The Fund may, but is not obliged to, use Equities to reduce risk and manage the Fund more effectively.</p> <p>Derivatives may be used to achieve the investment objective and reduce risk or manage the Fund more effectively.
